European open source community appeals to EU leaders

At the EU Digital Summit on 18 November, one key topic was missing from the agenda: open source. This was a major oversight, which the European open source community rightly criticised in an open letter to the heads of state and government. It served as a stark reminder of the central role that open technologies have already played in Europe's digital future. The letter emphasised that open source has significantly strengthened innovation, competitiveness, and sovereignty - and called on politicians to consistently support and expand this development. DAASI International was among the signatories.

Everyone is talking about digital sovereignty - but how sovereign is Europe really? And are we prepared for the growing power of global Al systems? In his statement, our CEO Peter Gietz offers a personal assessment. He highlights the widening gap between political ambition and technological reality, the close entanglement of the U.S. government with powerful Big Tech companies, and the GDPR as one of the key regulations increasingly coming under pressure. At the same time, he points to positive developments where genuine progress is visible - but is it enough?
